DEALER ACCOUNT APPLICATION PROCESS

Thank you for your interest in becoming a dealer for DOGGO RTT Ramp $^{\mathbb{M}}$. In this packet, you will find everything to start the process of becoming a dealer/distributor for DOGGO RTT Ramp $^{\mathbb{M}}$. Included in this document is a copy of our current Terms & Conditions and our Warranty policy.

DEALER QUALIFICATIONS

- 1. Provide a signed Terms & Conditions Forms
- 2. Provide a copy of Business License
- 3. Provide a copy of Tax-Exempt Resale Certificate(s)
- 4. Conduct business from a commercial location and/or have a fully functional website.
- 5. Dealer applicants must be industry related.

ORDERING

All orders placed for merchandise will be pre-paid at the time of the order entry. All orders MUST be submitted through the dealer portal on our website. Purchase orders or any other ordering methods are not accepted.

SHIPPING POLICIES

While we do our best to ensure your order is properly packaged before it leaves our facility, on occasion product may get damaged, be it a transport mishap, mishandled box, or a not so happy delivery driver. If this happens, please reach out to us as soon as possible. Then follow these steps:

DO NOT ACCEPT YOUR DELIVERY without taking note of any damage that might have occurred on the delivery form. Shipping companies will not fulfill an insurance claim without the damage being noted by the customer. We cannot be held responsible for any product or powder coat damage incurred during transit. DOGGO RTT RAMP™ will facilitate a claim, on the customers behalf with the carrier, but it is subject to the conditions listed above being met.

IF the damage is so severe that it is obvious the product inside has been damaged, do not sign for the item and refuse your delivery. If you sign for the package the shipping company will view it as rightfully yours and that you have accepted it AS IS.

IF the damage is less severe and the goods are intact, you can make a note of the damage on the delivery slip (or electronically with the driver) before signing for the delivery. This will begin the claims process and we will help you file a claim with the shipping company, but it will be your responsibility to replace or repair the product. All awarded claim money will be sent to the customer as reimbursement for shipping damage unless a prior arrangement has been made.

IF the package doesn't require a signature and it has been delivered while you were not present, and you discover that the package has been delivered damaged, please take photos of the damaged package before opening it. Next

contact DOGGO RTT RAMP™ via phone or email right away to explain that the package has been delivered damaged.

DOGGO RTT RAMP™ IS NOT LIABLE FOR PACKAGES THAT ARE MISPLACED OR STOLEN AFTER THEY HAVE BEEN DELIVERED. If you are worried about your shipment potentially getting stolen, please have the item delivered to a different address where someone will be available to receive it. After an order is shipped, you will receive tracking information so you will know when the item will arrive. DOGGO RTT Ramp™ will not refund or reimburse your order in any way if the package is misplaced or stolen once the tracking info shows delivered.

DOGGO RTT RAMP™ does NOT ship to PO box addresses!

Shipments outside the U.S. or to Alaska or Hawaii will have a higher shipping rate and require a shipping quote before ordering. Please email sales@doggorttramp.com with your full shipping address and a list of the products you would like to order. We will get a shipping rate quote from our shipping company and respond letting you know how much the charges will be. Our website will not accept addresses going to AK or HI or outside the U.S. so you will need to contact us to get a shipping rate quote first and then we can explain to you how to proceed with your order.

RETURNS

Purchases made at DOGGO RTT Ramp™ can be returned for any reason up to 30 days after receiving shipment. All returned products must be in like new, unmodified, resalable condition and include original packaging and all hardware. The cost of return shipping is the responsibility of the customer in addition to a 15% restocking fee. Any products that are determined to not be in new condition will incur an additional 5% fee. Products that have been customized or modified in any way are not eligible for returns.

CANCELLATION POLICY

You may cancel your order at any time prior to shipping and receive a full refund. If your item has been shipped, we accept returns of new, unused items in their intact, original packaging for up to 30 days after your order processing date. Returns for a refund are subject to a 15% restocking fee.

Buyer is responsible for all return shipping costs: Shipping costs are non-refundable.

LIFETIME WARRANTY

DOGGO RTT RAMP™ will warranty its DOGGO RTT RAMP™ product for the Lifetime of ownership after the shipping date of the product. This warranty will include any issues caused by manufacture defects. Any modification to the original product design, functionality, or use, by said customer voids all warranty eligibility. It is the sole discretion of DOGGO RTT RAMP™ to determine warranty eligibility. Our Lifetime Warranty is effective for as long as the original retail purchaser owns the product. This warranty terminates when the original retail purchaser sells or otherwise transfers the product to any other person.

DOGGO RTT RAMP™ reserves the right to remedy defects in workmanship or materials in one of three ways.

DOGGO RTT RAMP $^{\text{m}}$ will issue replacements components to the customer that deems defective or inconsistent with the quality of its brand.

This warranty does not cover defects caused by normal wear and tear, rust, scratches, accidents, or products used for racing/competition. This warranty does not cover damage to the finish of powder coated products. DOGGO RTT RAMP™ is not responsible for defects that are not in control of DOGGO RTT RAMP™ such as, overloading, incorrect assembly, poor maintenance practices or damaging acts of nature such as extreme weather e.g.: hail, flooding, lightning, extreme wind.

REPLACEMENT OF A DEFECTIVE PRODUCT OR THE ISSUANCE OF A REFUND (AS DETERMINED BY DOGGO RTT RAMP^M) IS A PURCHASER'S EXCLUSIVE REMEDY UNDER THIS WARRANTY. ANY AND ALL DAMAGE TO A PURCHASER'S VEHICLE, CARGO AND/OR TO ANY OTHER PERSON OR PROPERTY IS EXCLUDED.

DOGGO RTT Ramp $^{\mathbb{M}}$'s warranty obligations for all "Product(s)" are limited to defects in materials and workmanship, as solely determined by DOGGO RTT Ramp $^{\mathbb{M}}$ after careful inspection. Returns must include proof of purchase complete with date of purchase from DOGGO RTT Ramp $^{\mathbb{M}}$ or an authorized DOGGO RTT Ramp $^{\mathbb{M}}$ dealer/distributor.

DOGGO RTT Ramp^{\mathbb{M}} has adopted a Minimum Advertised Price Policy (MAP) for all DOGGO RTT Ramp^{\mathbb{M}} branded products. DOGGO RTT Ramp^{\mathbb{M}} 's MAP price is equivalent to the MSRP on DOGGO RTT Ramp^{\mathbb{M}} product(s).

DOGGO RTT Ramp^{\mathbb{M}} products have been established as a premium brand with a reputation for high quality. DOGGO RTT Ramp^{\mathbb{M}} has invested considerable resources in marketing and product development to build and maintain this reputation, establish a favorable marketing position and generate good will toward the DOGGO RTT Ramp^{\mathbb{M}} brand.

DOGGO RTT Ramp[™] supports and enforces our MAP Policy to prevent advertising that tends to depreciate or degrade the image and position of the DOGGO RTT Ramp[™] brand, products and trademarks in the marketplace maintaining the quality DOGGO RTT Ramp[™] rand reputation. By adopting a MAP policy, DOGGO RTT Ramp[™] Dealer/distributors and Customers benefit from enhanced profitability, loyalty and product image.

No part of DOGGO RTT Ramp™ 's MAP policy is designed to determine, control or influence the actual selling price of DOGGO RTT Ramp™ branded products. This MAP policy does not apply to the actual price at which products are sold in a retail location, over the telephone or in response to a customer inquiry. This MAP policy does not apply to signs or price tags located within a physical retail store and not visible from outside of a retail store. Authorized DOGGO RTT Ramp™ Dealers/ Distributors are free to set the actual retail price of each DOGGO RTT Ramp™ product.

For purposes of this MAP policy, "advertising" is defined as any form of media including, but not restricted to forms of social media, print, radio, television, billboards, brochures, posters, catalogs, letters, coupons, internet, E-commerce, direct mail, e-mail solicitations, e-mail newsletters, mass promotional mail, faxes, online auctions or any internet link to a website based shopping cart.

Any attempt to advertise DOGGO RTT Ramp™ products at prices other than set by this MAP policy directly or indirectly, including on the internet, will be considered an attempt to undermine the MAP policy and will therefore be considered a violation of the policy.

DOGGO RTT Ramp^{\mathbb{M}} products must be advertised at full MSRP, as listed on our website, inclusive of free shipping. If DOGGO RTT Ramp^{\mathbb{M}} runs a sales promotion, we will inform our dealers that they may lower their MAP for the duration of our sale to remain competitive. If we are running a promotion where you are allowed to lower your MAP, DOGGO RTT Ramp^{\mathbb{M}} will inform you.

PRODUCT DESIGN

We reserve the right, without notice, to change any material, specifications, part numbers or labeling without incurring any obligation to the buyer for past or future merchandise purchases.

INTELLECTUAL PROPERTY

DOGGO RTT Ramp™ maintains ownership of all brands, patents,

trademarks, logos, images, registrations and all other intellectuel, proprietary information for all DOGGO RTT Ramp™ products. Trademark infringement and counterfeiting will be dealt with to the fullest extent of the law.

TERMS & CONDITIONS

TO INDUCE DOGGO RTT RAMP™ TO EXTEND CREDIT TO CUSTOMER, CUSTOMER AGREES TO PAY ALL INVOICES WITHIN THE STANDARD TERMS OF THE SALES WHICH ARE "NET (15) DAYS" FROM THE DATE OF INVOICE. IF FOR ANY REASON ANY CUSTOMER CHECK IS RETURNED DUE TO NON-SUFFICIENT FUNDS, CUSTOMER WILL BE REQUIRED TO REPLACE THE ORIGINAL CHECK AMOUNT, ALONG WITH ANY ASSESSED BACK SERVICE CHARGES, WITH A CERTIFIED BANK CHECK UPON RECEIPT OF NOTIFICATION FROM DOGGO RTT RAMP™. CUSTOMER HEREBY GRANTS TO DOGGO RTT RAMP™ APPROVAL TO CONTACT THE TRADE AND BANK REFERENCES PROVIDED HEREIN. IF IT IS NECESSARY FOR DOGGO RTT RAMP™ TO PLACE CUSTOMER ACCOUNT IN THE HANDS OF A COLLECTION AGENCY OR AN ATTORNEY, CUSTOMER AGREES TO PAY THE COST OF COLLECTION PLUS THE COST OF ATTORNEY FEES, COURT COSTS, AND INTEREST AS PERMITTED BY THE LAWS GOVERNING THIS TRANSACTION. CUSTOMER UNDERSTANDS THAT DOGGO RTT RAMP™ MAKES NO COMMITMENT TO EXTEND CREDIT IN ANY PARTICULAR AMOUNT, AND THAT ANY EXTENSION OF CREDIT BY DOGGO RTT RAMP™ MAY BE WITHDRAWN OR DISCONTINUED AT ANY TIME, FURTHERMORE, DOGGO RTT RAMP™ MAY REFUSE TO EXTEND CREDIT FOR ANY SPECIFIC SALES ORDER OR IMPOSE ADDITIONAL CONDITIONS TO ANY EXTENSION OF CREDIT, IN ALL CASES AT DOGGO RTT RAMP™ 'S SOLE DISCRETION. CUSTOMER HEREBY STATES THAT ALL INFORMATION IN THIS APPLICATION IS TRUE AND CORRECT.
